The National FGM Centre's FGM Assessment Tool is an innovative and easy tool for social workers to use, which is complementary to current assessment methods, and enhances professional judgment by enabling holistic thinking about safety and risk factors.

The FGM Assessment Tool is based on the three domains of the social work assessment triangle and comprises of:

- A comprehensive guidance on FGM covering what it is, the law (including immigration issues), genograms and other activities and questions to use with families
- An **online assessment tool** which enables social workers to assess the FGM case, reflect on the recommendations and put safety plans in place.

The tool takes into account:

- Medical examinations
- Forced Marriage
- Mandatory reporting to the police of known cases of FGM for girls under 18yrs

The FGM Assessment Tool can also be used retrospectively to reflect on previous assessments.

Social workers piloted the tool and:

- 90% either felt confident or more confident to deal with suspected cases of FGM for under 18yrs old girls
- 100% strongly agreed/agreed that the training was useful and will help them in their role
- 90% reported that the training has made them reflect on how they could have assessed previous FGM referrals differently
- 100% reported that the training has increased their ability to assess an FGM referral and that they would recommend the training

Although the FGM Assessment Tool is self-explanatory and straightforward, the independent evaluation by York Consulting Limited recommends that:

"It is important therefore that the tool is not used in isolation from the training and resources provided through the National FGM Centre. Local authorities and other services who choose to adopt the tool as their method of assessing risk from FGM, should be encouraged to sign up for the one day familiarisation training and use the Good Practice Guide"
